2. All toilet blocks, terraces, and water tanks shall be periodically inspected every six (6) months for any signs of seepage, leakage, or flaking of concrete cover.
3. No excavation of any nature shall be undertaken within 3 meters of the plinth perimeter for any purpose whatsoever.
4. No slab shall be subjected to loading beyond its designed capacity or used for any purpose other than its intended use as a school facility.




